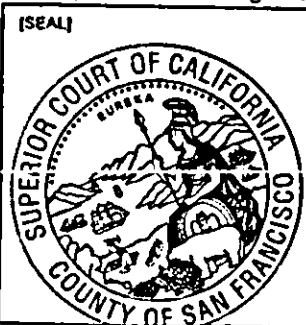



Specifically, on January 22, 2007, you threatened another tenant of the building in a common area of the building and when he walked away from you, you followed him into his room and swung at him with your fist, hitting his backpack and kicked his room door very hard. This conduct was done with provocation or justification. The San Francisco Police Department was called. Officers responded and you were served with a restraining order. Violence and/or threats of violence to anyone on the premises are absolutely forbidden and grounds for your immediate eviction.


