THIS NOTICE is intended for the purpose of terminating the rental agreement by which you now hold possession of the above-described premises. Your failure to deliver possession of the premises within three (3) days of service of this notice upon you will cause the undersigned to initiate legal proceedings against you to declare a forfeiture of your rental agreement, to recover possession of the premises, and to seek judgment for rent owed through the expiration date of this notice, with damages for each day of occupancy after that date.

THIS NOTICE complies with the San Francisco Administrative Code, Chapter 37.9(a), Subsection (3), in that: You are committing or permitting to exist a nuisance in, or are causing substantial damage to, the rental unit, or are creating a substantial interference with the comfort, safety or enjoyment of the landlord or other tenants in the building. Specifically, on June 10, 2007, you were burning a candle in your room and the candle fell onto your floor burning the carpet and the floor. While trying to put out the fire with water, you caused the ceiling for the room beneath yours to leak. On June 11, 2007, you were burning candles and paper in your room, which caused the smoke detector to activate. On June 12, 2007, you were again burning paper in your room, on your dresser, the floor and in the bathroom. The San Francisco Fire Department responded and then called arson investigators. The San Francisco Police Department responded and you were arrested for arson. Your above conduct demonstrated reckless disregard for the health and safety of everyone in your building. The fires that you started, if allowed to grow, could have destroyed property, injured or killed others in the building, and rendered other tenants homeless.
