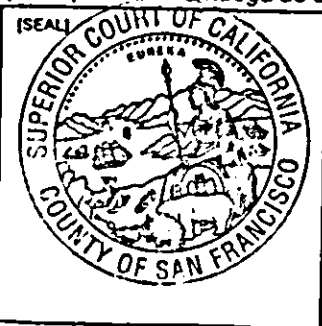

28 at and cursed the case manager. Shortly thereafter, you came back
and blocked the case manager's path to her office in the building,
to the bathroom there, and to other units in the building, again
yelling and cursing at her. Your conduct toward her frightened her
and caused her to seek a restraining order from the court against
you. Homophobic slurs, threats and intimidation against anyone in
the building is absolutely not tolerated by the landlord and are
grounds for your immediate eviction.
