

THREE DAY NOTICE TO PERFORM OR QUIT

TO: DIANA THOMPSON, 875 Post Street, #112, San Francisco, CA.
DOES 1 - 10, inclusive:

PLEASE TAKE NOTICE that you have been violating the visitor policy for the above premises. On May 1, 2006, you brought two visitors onto the premises without registering them, having them sign out, or present valid identification. On that date you left one of the visitors alone in the building when you left it, which is also in violation of the visitor policy. You gave that same visitor keys to the building without obtaining the permission of management to do so. Your willful refusal to follow the visitor policy jeopardizes the security and the quiet enjoyment of the premises for the other tenants in the building. You were admonished at a housing retention conference on March 15, 2006 by representatives of the landlord to abide by the visitor policy but you have failed and refused to do so.

WITHIN THREE (3) DAYS of service of this notice, you must: abide by each and every term of the visitor policy, a copy of which was provided to you, including, but not limited to, signing your guests in and out of the building, having them present proper identification in order to enter the building, and accompanying them at all times when they are on the premises and not giving them keys to the building during the entire duration of your tenancy at the above premises or deliver possession of the premises to ROGER PATEL, located at 875 Post Street, Manager's Unit, San Francisco, CA., who is authorized to receive possession by the landlord. Your failure to perform as stated above or to vacate the premises within three (3) days from the date of service of this notice will cause legal proceeding to be instituted against you to recover the above premises, to declare a forfeiture of your rental agreement, to seek judgment for any rent that may be owed through the expiration of this notice, together with damages for each day of occupancy after that date, and such other and further damages, costs of suit and attorney fees that may be allowed by law.

YOU ARE FURTHER NOTIFIED that the landlord elects to declare the forfeiture of your rental agreement under which you hold possession of the premises if you fail to perform as indicated above. Your rent will be due and payable to and including the date of termination of your tenancy.
